IMSc invites applications from the eligible citizens of India for filling up of one vacant unreserved post of Scientific Officer "C" [Library] by direct recruitment on regular basis.

**Essential Educational Qualifications :** Bachelor's Degree with first class followed by Masters Degree in Library and Information Science [M. Lib. Inf. Science] with First Class.

**Essential Experience:** The candidate must have a minimum of 4 years of Post qualification experience in a responsible capacity in a University Library / large Library of Academic (or) Research Institute.

**Desirable:** Working knowledge in a) Library Automation, Digitisation and networking, b) Acquisition and management of e-resources, c) Management of library operations and d) Experience in working with Library automation and management software.

**Pay Band:** Rs. 15600-39100 with Grade Pay of Rs. 5400/- plus allowances as applicable to Central Government employees stationed at Chennai. Higher starting band pay can be considered in deserving cases.
