### NOTICE INVITING TENDER FOR TWO PART TENDER

**Sealed tenders** in TWO parts are invited on behalf of the Director of Institute by the Registrar, The Institute of Mathematical Sciences, CIT Campus, Taramani, Chennai, Tamilnadu from experienced UPS contractors or who are on the approved list of the appropriate class of Central Public Works Department, State Public Works Department, Railways, Military Engineering Services, Public Sector Undertaking of Central / State Governments, Central Autonomous bodies or having similar experience with proven technical and financial capabilities. The tenderer should possess the required UPS system equipments and should have completed similar works (#) of any one of the following conditions.

i) Three similar works (#) each costing not less than the amount equal to 40% of the estimated cost put to tender during past seven years [or]

ii) Two similar works (#) each, costing not less than the amount equal to 60% of the estimated cost put to tender during past seven years [or]

iii) One similar (#) work of aggregate cost not less than the amount equal to 80% of the estimated cost during past seven years ending last day of the month previous to the one in which applications are invited.

The works completed upto previous day of last date of submission of tenders shall also be considered.

**Note:** The value of executed works shall be brought to current cost level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to last date of submission of tender.

Tender should be submitted in two parts : Part - I (Techno-commercial bid) containing the technical details and all the commercial points other than Price and Part - II (Price bid) should contain the Price. Part I and Part II should be kept in separate covers and sealed. EMD should kept in another cover. The cover should be superscribed as part I (Techno-commercial bid), Part II (Price bid) and EMD respectively. All the three covers should be kept in a big single envelope and the same should also be sealed. The tender number and date of opening should be written on top of the cover. Part I Techno-commercial bid will be first opened on the due date indicated below along with EMD. Part II will be kept under safe custody. The Part II Price bid should be valid for 180 days from the date of opening of part I (Techno-commercial). Part I (Techno Commercial bid) will be evaluated and the firm which are technically qualified will be intimated the date of opening of part II and the firm representative whose tenders are technically qualified will be permitted to participate in the opening of Part II (Price bid). The EMD submitted by technically non-qualified bidders will be refunded.

Tender documents can be had on written request made along with documentary evidence of having satisfactorily completed work involved with original certificates, turn over, solvency, man power with requisite value and duly recommended by the Scientific Officer (Electrical) on any working day from 03.04.2019 to 24.04.2019 on payment of the cost of tender document in cash in person along with documentary evidence for satisfactory completion of similar work (This amount is not refundable) from **The Accounts Officer, The Institute of Mathematical Sciences, CIT Campus, Taramani, Chennai 600 113.** Tenderer's shall furnish evidence of their past experience in the execution of similar UPS works with their annual turnover during the past 5 years and details of equipment handled along with their application for tender forms. The Institute is not responsible for any delay in receipt of tender document due to postal delay.

**Tenders not accompanied by the following are liable to be rejected.**

Demand Draft for the specified value from **a scheduled Bank** for the Earnest Money Deposit indicated above in favour of '**Institute of Mathematical Sciences**', payable at **Chennai.**

**Note: CASH, BANK GUARANTEE AND CHEQUES FOR EMD WILL NOT BE ACCEPTED.**

- 1 The tenderers should have similar experience in UPS system and it is mandatory.
- 2 EMD of successful tenderer will be returned immediately after submission of Performance guarantee.
- 3 Contractors who fulfill the following requirements shall be eligible to apply. Joint ventures are not accepted.
- 4 In the case of contractors in the approved list of public works Department, Central Public Works Department or Military Engineering Services shall be required to submit the copy of evidence showing the appropriate and eligible class to which they belong. Contractors are required to submit the detailed list of works carried out by them during the last seven years along with solvency certificate and the list of machines and manpower they possess. List of projects under execution or awarded shall also be submitted.

Should have an average annual financial turnover on electrical works of at least 100% of estimated cost during the immediate last 3 consecutive financial years (ie., 2015 to 2018, 3 financial years) certificate from Chartered Accountant to be enclosed. Should not have incurred any loss for more than two years during the last five years ending previous financial year. Details shall be furnished duly supported by figures in balance sheet / profit & loss account for the last 5 years duly certified by Chartered Accountant as submitted by the applicant to Income tax Department as per proforma as specified in

**Form – A.**

The bidding capacity of the contractor should be equal to or more than the estimated cost of the work put to tender. The bidding capacity shall be worked out by the following formula:

$$\text{Bidding Capacity} = [A \times N \times 2] - B$$

Where,

**A** = Maximum turnover in electrical works executed in any one year during the last five years taking into account the completed as well as works in progress. The value of completed works shall be brought to current costing level by enhancing at a simple rate of 7% per annum.

**N** = Number of years prescribed for completion of work for which bids has been invited.

**B** = Value of existing commitments and ongoing works to be completed during the period of completion of work for which bids have been invited.

Should have a solvency of 40% of estimated cost obtained from scheduled bank as per proforma specified in **Form – B** shall be enclosed. The solvency certificate shall not be older than one year from the tender opening date.

Applicant should enclosed the details of all works of similar class completed in the proforma as specified in **Form – C**.

**D)** List of projects under execution or awarded shall be enclosed as per proforma specified in **Form – D**.

- 5 The tenderer shall be required to place the Earnest Money and Technical bid and Financial bid in separate sealed envelopes marked '**Earnest Money**' and '**PART-I (Technical bid) and PART-II (Financial bid)**' respectively and these envelopes shall then be placed in another sealed envelope and submitted. The envelope containing the EMD shall be opened first. If the EMD is found to be in order then only the envelope containing the tender will be opened.
- 6 In case of successful tenderer, the tenderer is required to deposit an amount equal to 5% of the tendered value of the contract as irrevocable performance guarantee in the form of Bank Guarantee from State

*Bank of India or any one of the nationalized Banks or 'Demand draft from any scheduled bank drawn in favour of "The Institute of Mathematical Sciences" within a period of 15 days of issue of letter of intent. The letter of award of work will be issued only after the above said performance guarantee in any one of the prescribed forms is received and accepted failing which the Institute shall without prejudice to any other right or remedy available in law, be at liberty to forfeit the earnest money absolutely. Earnest money deposited along with bid shall be returned after receiving Performance Guarantee.*

- 7 In addition to the above, the successful tenderer is required to remit security deposit amounting to 2.5% of the tendered value which shall be deducted at 5% of the gross amount of the bill from each running bill, till total security deposit is recovered. Labour Welfare Cess @1% of gross value of work done shall be recovered from each bill paid to the contractor, and same will be remitted to "Tamilnadu Construction workers welfare board".
- 8 Tenderer must ensure to quote rate of each item. The column meant for quoting rate in figures. If any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO). **It will be assumed that the Contractor will execute the work at zero cost as he has added the cost in other items.**
- 9 The Department reserves the right to accept / reject any prospective application without assigning any reason thereof.
- 10 Short listing of the agencies shall be subject to thorough verification of their credentials and inspection of works carried out by them, through a Technical Evaluation Committee of experts, constituted by IMSc.
- 11 IF ANY INFORMATION FURNISHED by the applicant is found to be incorrect at a later stage, they shall be liable to be debarred from tendering / taking up works in IMSc.
- 12 Bidders shall not be under a declaration of ineligibility for tender quoting and fraudulent practice.
- 13 Documentary evidence of adequate financial standing.
- 14 Information regarding projects in hand, current litigation, orders regarding exclusion, expulsion or block entry if any to be furnished.
- 15 The capacity of the contractor to take up a new project under consideration in addition to his present commitments must be clearly brought out. He should also furnish the details referring as to have both physically and financially capable of executing this contract in the stipulated time as per milestones projected in addition to executing the other commitments.
- 16 Copies of original documents detailing the constitution or legal status, places of regulation and principle place of business, written power of attorney of regulation of the bond to commit the bidder.
- 17 The name of the tenderer shall be filled on the relevant pages of the tender form and all the pages shall be invariably signed and seal affixed including drawing attached (if any)
- 18 This tender document should be returned with all the papers intact without detaching any part of it.
- 19 Tenderer to note that tenders with any condition including that of conditional rebate shall be rejected forthwith.
- 20 A certificate to the effect that the firm had not been black listed by any Government Institute, Public sector undertaking or Autonomous Institutions, if so furnish the details.
- 21 Qualification and experience of key site management and technical personnel proposed for the contract.
- 22 Evidence of adequacy of working capital for this contract. Access to lines of credit and availability of other financial resources.
- 23 Information regarding any litigation, current or during the last five years, in which the bidder is involved, the parties concerned and disbursed amount.
- 24 Proposals for sub-contracting components of the works including the qualification and experience of the identified sub-contractor in the relevant field.

- 25 The proposed methodology and program of UPS system works, backed with equipment planning and deployment duly supported with broad calculation and quality control procedures proposed to be adopted, justifying their capability of execution and completion of the work as per technical specifications within the stipulated period of completion as per milestones.
- 26 Quoted rates shall be inclusive of all taxes, duties, and other government levies including GST and there shall not be any separate claim for same entertained.
- 27 Tender any condition including conditional rebate shall be rejected.
- 28 If the date for submission of tender and opening of tender happens to be a declared holiday at a later date, the same will be postponed to the next working day.
- 29 PF Clause :  
All the workers are to be paid applicable minimum wages. Provident Fund (PF) and Insurance schemes (if applicable ) for the workers shall be borne by the contractor. Records with respect to worker wages, PF, insurance, etc. shall be maintained and produced on demand for verification.
- 30 This Notice Inviting tender shall form a part of the tender document.
