# Tenderers are advised to take note of the following points into consideration while quoting:

- 1. E mail/ fax quotations will not be accepted.
- 2. The AMC period is to be 12 (Twelve) Months.
- 3. The payment will be made in four installments on pro-rate basis after completion of all preventive maintenance service during the contract period.
- 4. Late quotations will not be considered.
- 5. The tenderer should attach completed similar AMC works and work completion certificate from the organizations within last seven years is only the eligible to consider in the technical evaluation.
- 6. Quoting of final rates are inclusive of all taxes.

## A. AMC scope of works for Our FIRE ALARM SYSTEM:

The scope of works is involved for service and maintenance of fire alarm systems in good working condition and replacement of all worn out parts as required.

This comprehensive AMC shall cover for free replacement of all the accessories including smoke detectors, main fire alarm control panel and its all spare parts, manual call points, isolator module, signal module, repeater panel, response indicator, Auto dialler, battery, hooters and Horn strobe units etc. as indicated in the list of equipments.

The service providers shall attend the complaints / breakdown calls immediately on receipt of our complaint.

The detectors shall be cleaned periodically and the sensitivity should be maintained for good working condition.

The details of testing and its reports shall be stored in the fire alarm panel electronically for the case study and one hard copy should be kept in main panel for further reference.

The drawn up plan of action for the servicing of these systems has to be submitted to engineer-in-charge in writing in advance.

All service / maintenance / breakdown works will be carried out during regular working hours on any working day which is convenient to the Institute.

The service provider should ensure that the fire alarm systems are maintained in trouble free working condition.

The service providers shall replace only the original equipment manufacturer spare parts / materials and this is to be carried out with prior approval by engineer-in-charge of IMSc to ensure original equipment technical specifications and standards.

If any of the equipment is not functioning properly during the contract period due to deteriorated condition / beyond repairable condition / change of versions / changes of original manufacturer model specifications, it is to be replaced immediately with free of cost to restore our fire alarm system.

## Required preventive maintenance program and the schedules are follows:

### Monthly Testing:

- a. Functional test of Power Supply module and loop cards in the control panel.
- b. Test of loop card with one detector randomly selected in an area along with the hooter / siren.
- c. Testing of Hooters / siren and manual Call Point.

#### Quarterly Testing:

- a. All the detectors will be removed and clean dust and dirt.
- b. Each detector after cleaning will be tested, fixed at its original location and verified with the panel.
- c. Checking of power supply modules, CPU, Loop Card will be done through external components like detectors, Manual Call Points etc.

The service provider shall undertake all routine maintenance / emergency breakdown calls in addition to above said all testing / maintenance program for our fire Alarm System.

## C. Condition of contract for this AMC:

Terms and conditions for Comprehensive Annual Maintenance Contract for fire alarm systems installed at Institute premises shall be as follows:-

- 1. All the rates must be quoted in the prescribed format only. The company profile and a list of customers etc. must be accompanied with the tender document.
- 2. The rates quoted shall be valid for 90 days from the date of opening of tender. Similar works means Comprehensive AMC service carried out for minimum 12 months for all the accessories of FA system like Fire alarm panel (EST-3) with loop cards including addressable smoke detectors, main fire alarm control panels and its all spare parts, manual call points, isolator modules, signal modules, repeater panels, response indicators, Auto diallers, batteries, hooters, Horn strobe units, VESDA system and FM 200 gas contained fire protected systems etc.
- 3. If the contractor fails to repair the system within 24 hours of complaint due to irresponsible / without proper reason, they will attract a penalty of Rs. 200/- per day till the restoration of entire system. If the problem is continous, IMSc is right to terminate the AMC contract immediately.
- 4. The contractor shall compensate in full the loss sustained by this institute on account of damage or theft of material during discharge of the activities by the service provider.
- 5. The staff provided by the contractor to the Institute are in case found to be indulging in any undesirable or unfair activities in the premises of the office, the contractor will solely be responsible for all the consequences apart from the liberty of office to lodge complaints before appropriate authorities.
- 6. The Institute will not take any responsibility in case of any accident / injury to the labourers during working. The firm shall take all safety measures and welfare of the labourer.
- 7. Any damage is caused to any equipment / items available at the Institute premises due to negligence of the contractor's work force shall be entirely on contractor, the amount so involved on this account shall be deducted from the payment due to contractor.
- 8. The Institute is right to withhold the payments of the contractor in case of dispute till it is resolved.

- 9. Service charges accepted shall be firm during the currency of the contract. Payment will be maybe on quarterly pro rata basis after completion of the preventive maintenance work. It is the responsibility of the service provider to obtain the satisfactory completion certificate from Incharge (Elec.) after completion of each service and submit the same along with bill for payment.
- 10. Security deposit (5%) will be deducted from the AMC bills and it will be returned to the service provider after completion of satisfactory AMC works.
- 11. It is mandatory to have their professional service centre in Chennai by the AMC firm suitable for our audio systems.
- 12. Neccessary IT and TDS will be deducted form the bills as per Government norms.
