

2) Any quotation, which does not fulfill any of the prescribed conditions or is incomplete in any respect, is liable to be rejected.

General Conditions:

1. The quotations shall be in the prescribed form which can be obtained from Office of Accounts Officer, The Institute of Mathematical Sciences, Taramani, Chennai-113, on submission of proof showing relevant experience in executing work like 11 KV/ 433 V Electrical Substation AMC, Lighting, various LT equipments & Transformer Preventive maintenance AMC on submission of a request in writing for issue of tender documents.
2. Experience of having successfully completed any of the (in last four years)
 - a) 3 works completed each costing not less than 40% of estimated cost i.e Rs. 9.86 lakh
 - b) 2 works completed each costing not less than 60% of estimated cost i.e Rs. 14.79 lakh
 - c) 1 works completed each costing not less than 80% of estimated cost i.e Rs. 19.72 lakh
3. EMD Rs. 49,319/- (Rupees forty nine thousand three hundred and nineteen only) shall be in the form of Demand Draft from any of the Nationalized Bank drawn in the name of "The Institute of Mathematical Sciences" payable at Chennai.
4. In case of Tenderer is unwilling to quote his offer, he must return all the documents forthwith.

7. The contractors shall provide Employees Provident fund, Employees state Insurance or Health Insurance etc. as laid down in the ACT.
8. The contractors desire to purchase the tender document shall intimate in advance the name and designation of the authorized representative coming to collect the document.
9. IT @ 2% and WCT @ 5% or as applicable shall be deducted from the bills.
10. Quoted value shall be inclusive of ESI, EPF and service tax components.
11. Tender and EMD shall be placed in two separate envelopes clearly indicating tender No. and each market as TENDER & EMD respectively.
12. Both the envelopes shall be submitted together in another sealed envelope superscribing Tender no and description of work along with due date and time of submission on the outer cover.
