This individual participates in technical research and development to enable continuing innovation within the infrastructure as well as its day-to-day maintenance and upgrade. This individual ensures the related procedures adhere to organizational values, enabling staff, student, faculty members to carry out multiple activities in collaboration with national and international agencies. Readiness for maintaining the facility on 24x7 is essential.

Mode of Selection	Level I: Written test: Objective type test will be held at Chennai only.	Applicants who fulfill the eligibility criteria only will be screened-in and called for Written test and the date, time and venue will be intimated through Email separately besides displaying the list of screened-in applicants on our web-site. Written test will be only screening test to shortlist candidates for Practical Test and Interview. Document verification: Candidates would be required to produce the relevant certificates in original for verification and submit one set of attested copies for records before the commencement of written test. If certificates produced by candidates are not valid, such candidates will not be permitted to appear for Written test. Further, their candidature will be cancelled.
