The Institute admits students after their M.Sc./M.Tech degree (or) B.Sc./B.Tech Degree for pursuing and obtaining doctoral degrees under Ph.D/Integrated Ph.D. programmes of 5 years and 7 years respectively in the disciplines of Theoretical Physics, Mathematics, Theoretical Computer Sciences and Computational Biology. This Institute is one of the Aided Academic Institutes under the Department of Atomic Energy, Government of India. IMSc is fully funded by the Department of Atomic Energy and partially funded by the Government of Tamil Nadu.

IMSc is looking for a dynamic and highly knowledgeable **Deputy Controller of Accounts** who will be responsible for all the financial, accounting and budgetary functions of the Institute.

Job Description:

The primary functions of the incumbent to the position will be to maintain and deal with all the financial aspects of the Institute, including disbursement of salaries to the members of the Institute, pension to former members, fellowships and other entitlements to the research scholars, managing the accounts of the Institute as per the provisions of the extant rules of the Government of India and as provided in the Bye-laws of the Institute, provident funds, pension payments, contributions to the New Pension Scheme, accounts of external projects and external grants, preparation of Annual Accounts and Audited Statements, Handling Audit matters, etc.

Mode of Selection	<u>Level I:</u> <u>Written test :</u> Objective type test will be held at Chennai only.	Applicants who fulfill the eligibility criteria only will be screened-in and called for Written test and the date, time and venue will be intimated through Email separately besides displaying the list of screened-in applicants on our web-site. Written test will be only screening test to shortlist candidates for Interview. Document verification: Candidates would be required to produce the relevant certificates in original for verification and submit one set of attested copies for records before the commencement of Interview. If certificates produced by candidates are not valid, such candidates will not be permitted to appear for Written test. Further, their candidature will be cancelled.
	<u>Level – II</u> <u>Interview :</u> Will be held on a different date at Chennai only.	The candidates who are shortlisted only will be called for Interview on the basis of cut off marks and the date, time and venue will be intimated separately through Email, besides displaying the list of shortlisted candidates on our web-site. If there is more than one candidate with the same cut off mark, then all the candidates with the same marks will be shortlisted for Interview. However, obtaining the cut-off marks alone does not entitle a candidate to be called for Interview.

1. Applications will have to be submitted through **ONLINE** only.
2. Candidates who have not acquired required educational qualification as on the closing date for receipt of application (**i.e. 10.12.2023**) need not apply. No further correspondence or clarification can be entertained on this matter.
3. Candidates are requested to go through carefully the details of post and instructions.
4. Candidates working in Government / Semi Government / Public Undertakings / Autonomous bodies should apply through proper channel and they should submit a “**No Objection Certificate**” from the present employer.
5. Only screened in applicants will be called for written test. Only shortlisted candidates as explained above will be called for Interview.
6. Candidates are required to have a valid Email ID and Mobile Number & convey the same in the application. It should be kept active during the currency of this recruitment. IMSc will send intimation / call letters only through the registered email ID.
7. Any subsequent amendments / modifications etc. on this matter will be notified only in IMSc website under the page “**Recruitment of Deputy Controller of Accounts**” under **Other Positions** under **Opportunities page** (https://www.imsc.res.in/other_positions) which may be referred to by the candidates regularly.
8. Before applying for the post, candidates should ensure that they fulfill all the eligibility norms. Candidates should have the requisite Educational & other Qualifications from recognised University / Institute as on the date of submission of the application.
9. Period of experience and age as prescribed in the Advertisement will be determined with reference to the last date for submission of application.
10. Mere fulfillment of requirements as laid down in the Advertisement does not entitle a candidate to be called for written examination.
11. Incomplete applications shall be summarily rejected.
12. At the time of written examination, candidates must bring a printout of the call letter sent to them through email printed properly with header.
13. The candidates belonging to SC category are required to submit caste certificate at the time of appearing for written test to claim reimbursement for to and fro second class (General Class) railway fare / bus fare by the shortest route or the actual fare paid whichever is less, subject to production of original tickets, etc.
14. The prescribed qualification are minimum and mere possession of the same does not entitle candidates to be called for written test. The decision of the Director of this Institute in all matters will be final and binding on the candidates and no enquiry or correspondence will be entertained in this matter.

The selected candidates will be governed by new re-structured defined contribution Pension Scheme (National Pension Scheme), which has come into force w.e.f. 1.1.2004 vide Ministry of Finance Notification No. 5/7/2003-ECB&PR dated 22.12.2003 and the provisions made there under by contributing monthly an amount of 10% of pay and Dearness allowances and 14% contribution from Government.
16. Probation : The person selected will be appointed on probation as per rules.
17. IMSc reserves the right to accept or reject any application at any stage of the Recruitment process, if the candidate is found ineligible for the post. The decision of Director, IMSc shall be final in deciding the eligibility of the candidate. The mere fact that a call letter has been issued to the candidate and allowed to appear in written examination will not imply that his / her candidature has been finally cleared or that entries made by the candidate in his / her application have been accepted as true and correct.
18. Director, IMSc reserves the right to cancel the whole process of recruitment without assigning any reasons thereof and decision of the Director, IMSc, is final in all respects.
19. Evaluation of answer papers of the written test will be completed and results will be published on the IMSc website.
20. The validity of operation of wait list, if drawn, will be one year from the date of preparation of the Select Panel. The wait listed candidate will be offered the post only in case of non joining of selected candidate / resignation of selected candidate after joining the post within one year from the date of drawal of the wait list.
