- 1 EMD of successful tenderer will be returned immediately after submission of Performance guarantee.
- 2 Contractors who fulfill the following requirements shall be eligible to apply. Joint ventures are notaccepted.
- 3 In the case of contractors in the approved list of public works Department, Central Public Works Department or Military Engineering Services shall be required to submit the copy of evidence showing the appropriate and eligible class to which they belong. Contractors are required to submit the detailed list of works carried out by them during the last seven years along with solvency certificate and the list of machines and manpower they posses. List of projects under execution or awarded shall also be submitted.

The letter of award of work will be issued only after the above said performance guarantee in any one of the prescribed form is received and accepted failing which the Institute shall without prejudice to any other right or remedy available in law, be at liberty to forfeit the earnest money absolutely. - 6 In addition to the above, the successful tenderer is required to remit security deposit amounting to 2.5% of the tendered value which shall be deducted at 5% of the gross amount of the bill from each running bill, till total security deposit is recovered.
- 7 Tenderer must ensure to quote rate of each item. The column meant for quoting rate in figures. If any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is

quoted by the bidder, rate of such item shall be treated as "0" (ZERO). It will be assumed that the Contractor will execute the work at zero cost as he has added the cost in other items.

- 8 The Department reserves the right to accept / reject any prospective application without assigning any reason thereof.
- 9 Short listing of the agencies shall be subject to thorough verification of their credentials and inspection of works carried out by them, through a Technical Evaluation Committee of experts, constituted by IMSc.
- 10 IF ANY INFORMATION FURNISHED by the applicant is found to be incorrect at a later stage, they shall be liable to be debarred from tendering / taking up works in IMSc.
- 11 Bidders shall not be under a declaration of ineligibility for tender quoting and fraudulent practice.
- 12 Documentary evidence of adequate financial standing.
- 13 Information regarding projects in hand, current litigation, orders regarding exclusion, expulsion or block entry if any to be furnished.
- 14 The capacity of the contractor to take up a new project under consideration in addition to his present commitments must be clearly brought out. He should also furnish the details referring as to have both physically and financially capable of executing this contract in the stipulated time as per milestones projected in addition to executing the other commitments.

- 25 Quoted rates shall be inclusive all taxes, duties, and other government levies including GST and there shall not be any separate claim for same entertained.
